The law also prohibits the prosecutions of "any person for conduct relating" to a legally consented to abortion. Today, 38 U.S. States legally recognize a human fetus or "unborn child" as a crime victim, at least for the purpose of homicide or feticide laws.

A fetus or foetus (/ ' f i: t ə s /; plural fetuses, feti, foetuses, or foeti) is the unborn offspring of an animal that develops from an embryo. Following embryonic development the fetal stage of development takes place. In human prenatal development, fetal development begins from the ninth week after fertilisation (or eleventh week gestational age) and continues until birth.
