Private Placement Offerings All offers or sales of securities must either be registered or qualify for an exemption from registration. Sections 3 and 4 of the Securities Act of 1933, as amended (“Securities Act”) set forth the exemptions available for certain transactions and certain offerings.

Rule 5123 (Private Placement of Securities) requires firms to file with FINRA's Corporate Financing Department within 15 calendar days of the date of first sale of a private placement, a private placement memorandum, term sheet, or other such offering documents. Alternatively, the firm must indicate that no such offering documents were used.

Courts, reviewing private placements when challenged, weigh investor access to underlying information about the transaction very heavily in the determination of whether there has been compliance with the private placement exemption.

Rule 506(b) of Regulation D is considered a “safe harbor” under Section 4(a)(2). It provides objective standards that a company can rely on to meet the requirements of the Section 4(a)(2) exemption. Companies conducting an offering under Rule 506(b) can raise an unlimited amount of money and can sell securities to an unlimited number of accredited investors.
