This is a simple band performance contract for small shows. It includes the all-important free tix, parking, and munchies/water. Please note the mandatory sound check of Venue's systems -- the Band needs to take the lead in setting that up. Disputes are settled by inexpensive arbitration. Bands may prefer to use a small claims court in their hometown.

The agreement that musicians perform is subject to detention by sickness, accident, riot, strikes, epidemic, acts of God or other legitimate conditions beyond their control. Disputes - In the event any dispute arises under this Agreement that results in litigation or arbitration, the prevailing party shall be paid its reasonable attorney's fees and costs by the losing party.
