Definition of the Jury System

Juries are most common in common law adversarial-system jurisdictions. In the modern system, juries act as triers of fact, while judges act as triers of law (but see nullification). A trial without a jury (in which both questions of fact and questions of law are decided by a judge) is known as a bench trial .

Criminal laws (and therefore laws around juries) are legislated by state, not federally, in Australia. Queensland was the first state to allow women to serve on juries, and that was back in 1924, but according to the state library of Queensland's archives, the first female juror wasn't actually empanelled until 1945.

It took the United States a while to recognize the right to a jury in all criminal cases, state or federal, felony or misdemeanor, but the present state of the law is that the Sixth Amendment of the U.S. Constitution guarantees a jury trial to anyone facing a potential penalty of at least six months' imprisonment.

First, juries are not called upon to explain their verdict—unlike civil cases, where juries may be asked to answer specific questions about their conclusions, a criminal case usually results in only one of two verdicts: Guilty or not ...

The jury member is first sworn in to work as a member of 12 randomly selected panel who listen to the evidence in criminal cases in the Crown Court.

The common law system was an improvement on what had gone before, but it was still slow, highly technical – making procedural mistakes that could ruin a case all too likely – and vulnerable to corruption, especially when juries were used.

The Jury System

The jury does not interpret the law. It follows the directions of the judge as regards legal matters. During all stages of the trial, jurors may take notes of proceedings. Jurors may also pass notes to the foreman or forewoman of the jury to ask the judge to explain certain aspects of the case.

Jurors sometimes exercise their right to protest against a law that they consider unfair or unjust by voting "not guilty" even though the defendant is guilty of violating that law. This practice is called jury nullification and it goes back to colonial times.
