Liberal Pluralism is a brief book on three large topics: pluralism as a theory of value, liberalism as a theory of politics, and the relationship between the two. Clear, timely and suggestive, the argument attempted in such short compass is also inevitably incomplete and at points sketchy. By value pluralism Galston intends the view that not all values are commensurable: they may neither be reduced to a single over-arching value nor completely rank-ordered.

The Practice of Liberal Pluralism operates an interesting synthesis on this point. Galston defines himself as a liberal pluralist such as Berlin, but although he acknowledges that conflict between values can be tragic, he minimizes this aspect in the following discussions, and considers the possibility of having prima facie duties (cf. the discussion on his rejection of moral particularism).
